<u>WFS</u> Tony Belline – Quiet month as the fiscal year winds down. Thank you, Tony, for your service to the council over the past 3 years as Financial Secretary.

Treasurer's Report

WT Mike Reynolds reported the opening balance for May was \$17,347and ended at 20,163.81. There were \$9590 of deposits with the Golf Tournament (\$9188) making up the majority of deposits. There were \$6774 of withdrawals with the golf tournament expenses (\$5151), State Conv. Expenses & name badges (\$952) and State per capita dues (\$400) making up the major withdrawals. As the financial year comes to an end in June, the balance will be reduced as money is distributed to our charities.

The Staddon-Cain Investment Account gained \$225 in market value adjustment, and gained \$98 in Dividends and Interest resulting in a closing balance of \$22,944.04. See the list and amounts under New Business.
