Financial Report - WFS Paul LUtgen

\$11,500 spent, includes \$6000 going out for the fire pit, \$5000 for LAMB, and \$500 for Room at the Inn. Dues are trickling in. We are at +2 for the year with 136 members.

Treasurer's Report - WT Mike Reynolds

Opening balance was \$12,038.07 and ended as \$13,164.67. There were deposits for dues (\$35), pancake breakfast proceeds (\$450), donation from a parishioner (\$50), from last meeting (\$100.08), DASH proceeds (\$874.42), from last meeting (\$42) and funds moved to special projects (\$1798). There were \$428.42 of withdrawals made with general account (\$209.50), Robly reimbursement to David Kempka (\$4.75), liability insurance to State Council (\$204.75), and reimbursement to Stan for the pancake breakfast (\$218.92). Ending balance is \$13,164.67

The Staddon-Cain Investment Account had an opening balance of \$23,732.77, gained \$261.61 in market value adjustment, and gained \$112.08 in Dividends and Interest resulting in a closing balance of \$24,106.35. See the list and amounts under New Business.
